

EcoCash Remit “Wake-UP” Competition Terms and Conditions

General Rules

1. The competition is organised by Worldstream (Pty) Limited trading as Econet Wireless South Africa (“EWSA”) and Cassava Fintech (Pty) Limited.
2. Directors, employees and contractors of EWSA and Cassava Fintech or their relatives are not eligible to enter the competition and cannot win prizes.
3. Competition is targeting at reviving EcoCash Remit clients that have never remitted since registration or that have not remitted in the last 4 months (April, May, June, July)
4. The competition will run from Tuesday 13 August until Friday 13 September 2019.

Prizes

1. Prize draws will commence on Monday, following a week’s trading activity. The first draw will take place on Monday 19 August 2019 for all entries qualifying prior to that date.
2. Thereafter, weekly prize draws will take place from all entries qualifying prior to each draw.
3. Only nine winners will be drawn per week per province.
4. The weekly prize draws will be R500 per winner per week.
5. If a customer transacts a minimum of R750 to Zimbabwe via EcoCash Remit, then they stand a chance of winning R500 cash back.

How to Enter and Awarding of Prizes

1. To participate you must be over the age of 18 years or older.
2. The cash prizes will be paid electronically into a South African bank account of the winner’s choice. Prizes will not be paid in physical cash.

Winners will have 14 days from being notified that they have won to advise, in writing, an account to be used for the cash prize payment; failing which they shall forfeit the prize and a replacement winner will be drawn.

NEW CUSTOMERS

1. Any new customer who registers for Ecocash Remit and sends a minimum of R500 to Zimbabwe via Ecocash Remit will stand a chance to win R500 cash back. New registrations after the start date will be legible for the competition (start date 13 August 2019)

EXISTING CUSTOMERS

1. Existing customers must have been registered prior to the start of the competition and have not remitted to Zimbabwe via EcoCash Remit in order to qualify.
2. Existing customers who have not used the EcoCash remit services for the last 3 months (since 1 April 2019) will be entered into the prize draw
3. Existing customers will be entered into the prize draw by sending a minimum of R750 to their loved ones in Zimbabwe via EcoCash Remit during any week of the competition, which closes on 13 September 2019. (the draws will be done on a weekly basis all R750 or more will be entered into the draw)
4. The more you transact the more entries you receive. Agents are encouraged to refer as many clients as possible to help grow the EcoCash Remit family
5. All cash prizes will be deposited into a valid South African Bank Account
6. Within two business days of the draw date, EWSA will contact winners telephonically on the same cell phone number number they used to send money with. We will attempt to call the winners three times within 48 hours of making the draw. If we are unable to contact you, you shall forfeit the prize and you shall have no claim against EWSA in this regard.
7. Any prize not claimed within 30 days of the winner being notified shall be forfeited.

If You Are a Winner

1. You will be required to confirm the full name(s), surname(s) and cell phone number(s) of your recipient(s) in Zimbabwe
2. If you cannot provide such proof, you will not be eligible for the prize and you shall forfeit the prize.
3. EWSA will arrange that the Cash prize be deposited into your valid South African Account number. We will inform you when we intend to do the deposits.
4. If you are a winner, EWSA may ask you if we can publish your name and photograph at no cost to you, for any advertising, promotional, print, point of sale, TV or public relations material for 12 months from the end of the competition period. It is our intention to publicise the prize winners through the above-mentioned media and communications platforms, however you are entitled to say no to this request.
5. Should you consent, you shall have no claim against EWSA for the use of your photo and name in the abovementioned communications platforms with the aforementioned period.
6. It is important to understand that all participants and winners indemnify Econet CALL HOME, Cassava Fintech, its directors, affiliates, members, partners, employees, agents, consultants, suppliers, contractors and sponsors against any loss or damages, either direct or indirect, consequential or otherwise, arising from its participation in this competition.
